OFFICE ORDER

The pendency position of Adjudication in Nagpur Zone at Deputy / Assistant Commissioner level as on 31.05.2022 in respect of Service Tax is huge in Nashik and Aurangabad. The total number of cases stands at 12503 cases (i.e. 8686 Nos in Nashik, 3038 Nos in Aurangabad, 491 Nos in Nagpur - I and 288 Nos in Nagpur - II Commissionerate). Since there are 44 DCs / ACs in this Zone, the cases have to be equally divided and redistributed amongst them.
