**OFFICE ORDER**

The pendency position of Adjudication in Nagpur Zone at Additional / Joint Commissioner level as on 31.05.2022 in respect of Service Tax is huge in Nashik and Aurangabad. The total number of cases stands at 1459 (i.e. 859 Nos in Nashik, 595 Nos in Aurangabad, 03 Nos in Nagpur - I and 02 Nos in Nagpur - II Commissionerate). Since there are 12 ADCs / JCs in this Zone, the cases have to be equally divided and redistributed amongst them.
