Normal cut of date for transfer & rotation, as per transfer policy 2015, is 30 th June of every year. However as a onetime measure to streamline the process of AGT i.e. ensuring the transfer, posting and relieving in time bound manner two months grace period is being given from cut of date. Hence officers due for transfer in the month of July & August shall be considered in AGT 2016 and the officers due for transfer in the month of October onwards shall be considered in the AGT of next year, whereas there is no officer due for transfer in the month of September. Those officers who are being considered for the AGT of next year under this scheme can represent to be considered in the AGT 2016.
