Sub: Turant Customs – All India roll-out of Faceless Assessment...

Kind attention of all the Importers/Exporters/Custom Brokers/Trade Associations and all other Stakeholders are hereby invited to the Board's Circular No.28/2020-Customs, and Instructions No.09/2020 both dated 05/06/2020, Circular No.34/2020-Customs, dated 30/07/2020 and Circular No.40/2020-Cusrtoms dated 04/09/2020 launching All India roll-out of Faceless Assessment, under the umbrella of the next generational **Turant Customs** programme. It is being rolled out for items of import primarily covered by Chapter 39 of the Customs Tariff Act, 1975 for Nagpur Zone w.e.f. 15/09/2020.

2. The Board has decided to begin the implementation of faceless assessment phase wise. Thus, the next phase of Faceless Assessment covering the imports primarily under the specified Chapters of the Customs Tariff Act, 1975 for Nagpur Zone is as under :-

Further, for monitoring and ensuring speedy and uniform assessments in the Customs Zone, in regard to Bills of Entry assigned by the Customs Automated System to the Officers of the Faceless Assessment Groups, the Commissioner of Customs, Nagpur will be the Nodal Commissioner. The Commissioner of Customs, Nagpur shall administer, monitor and ensure speedy and uniform assessments of Bills of Entry assigned by the Customs Automated System to the Officers of the Faceless Assessment Groups with the jurisdiction of the Customs Commissionerate Nagpur.

04. Further, in terms of Notification No.85/2020-Customs(N.T.) dated 04/09/2020 issued for the purpose of empowering the Commissioner of Customs (Appeals), Nagpur shall take up appeals filed in respect of Faceless Assessments pertaining to imports made in his/her jurisdiction even though the assessing officer may be located at the other Customs station.

05. All other clarifications and guidelines on Faceless Assessment, as provided vide Circular No.28/2020-Customs and Instruction No.09/2020-Customs, both dated 05.06.2020 and PN No.14/2020 dated 14.08.2020 issued by this office and further Public Notices issued by other Commissionerates may kindly be referred to.
