Sub: Launch of Indian Customs EDI System - (ICES - 1.5) for Imports and Exports, at ICD (CONCOR), at MIHAN Area, Khapri Village, Nagpur, [INKPK6]- Regarding

Kind attention of Importers/Exporters, Customs Brokers & Trade Associations is invited to CBEC Notification No.12/1997-Customs(N.T.) dated 02/04/1997 issued under Section 7(aa) of the Customs Act, 1962 wherein, inter alia, Nagpur was appointed as Inland Container Depot for the purpose of unloading of imported goods and loading of export goods.

- 2. The Commissioner of Customs, Nagpur vide Public Notice No.21/2017-Cus. dated 03/10/2017 issued under section 8(a) of Customs Act 1962 declared the premises of Multimodal Logistic Park (MMLP) in MIHAN Area of Khapri village, Nagpur Customs area for the purpose of handling of Import & Export Cargo at the Inland Container Depot. Further, limits of Customs Areas located at ICD MIHAN, Nagpur was also defined under section 8(b) of Customs Act 1962.
- 3. The said Public Notice No.21/2017 was superseded by Public Notice No.07/2019 dated 08/01/2019 issued under wherein the limits of the Customs Area in the layout plan of Multimodal Logistic Park (MMLP) in MIHAN Area of Khapri village, Nagpur, was delineated as under:-

North: Part of MADC Plot No.5A of M/s CONCOR (Length 302.5 meters)
South: Part of MADC Plot No.5A of M/s CONCOR (Length 302.5 meters)
West: Part of MADC Plot No.5A of M/s CONCOR (Length 289.0 meters)
East: Part of MADC Plot No.5A of M/s CONCOR (Length 258.0 meters)

- 4. The Commissioner of Customs, Nagpur vide Public Notice No.08/2019 dated 08/01/2019 issued under Section 45(1) of the Customs Act, 1962, appointed M/s Container Corporation of India Ltd. (CONCOR) MIHAN, Nagpur as Custodian of all imported goods and goods to be exported through containers by Rail and Road movement, to and from Gateway Ports till the goods are cleared for home consumption, or for warehousing or for transshipment and for export at ICD (CONCOR), at MIHAN Area, Khapri Village, Nagpur in accordance with the provisions of the Customs Act, 1962.
- 5. The Principal Chief Controller of Accounts, CBIC, New Delhi vide his Office Memorandum issued vide F.No.Coord/2(1)/Nagpur(52)/2018-19/243 dated 24/08/2018 has conveyed the approval for authorization of State Bank of India, Chhaoni Branch,

6. The Directorate General of Systems, CBIC, New Delhi vide their Office Memorandum issued under F.No.IV(26)/47/98-Systems/Pt.XIX/623 dated 06/11/2017 has allocated the Location Code to ICD, MIHAN as under:-

- 7. Further, the pre-production trials for EDI connectivity were completed on 12/09/2019 by the team of officers and the report was submitted on 27/12/2019. The said report of successful completion of pre-production trials has been communicated to the DG Systems, CBIC, New Delhi.
- 8. Accordingly, it has been decided that the computerized processing of Bills of Entry and Shipping Bills under the Indian Customs EDI (Electronic Data Interchange) system, [ICES 1.5] will commence from <u>01/01/2020</u> at M/s Container Corporation of India Ltd. (CONCOR), MIHAN Area of Khapri Village, Nagpur.
