Attention of the Customs Brokers and other members of trade is invited to Board's Notification No. 62/2021-Customs (N.T.) dated 23.07.2021 and Circular No. 17/2021-Customs dated 23.07.2021 wherein as per amended Regulation 9 of CBLR 2018, a license granted under Customs House Agents Licensing Regulations, 1984, the Customs House Agents Licensing Regulations, 2004, the Customs Brokers Licensing Regulations, 2013 or the Customs Brokers Licensing Regulations, 2018 shall be valid unless and until revoked in terms of provisions under sub-regulation(2) of Regulation 8A or Regulation 14.

2. The Customs Brokers Licenses Management System (CBLMS)online Portal was introduced on 17.10.2022. In view of this, the Customs Brokers whowere issued license in Nagpur Customs Commissionerate under Regulation 7(2) of CBLR 2018 or corresponding provisions of earlier CBLR, whose license is operational and are fulfilling other conditions as laid down in Customs House Agents Licensing Regulations, 1984, the Customs House Agents Licensing Regulations, 2004, the Customs Brokers Licensing Regulations, 2013 or the Customs Brokers Licensing Regulations, 2018 are requested to apply online on CBLMS Portal for life time validity before the expiry of the current CB License.
