**AUCTION NOTICE**

**Subject:- Disposal of condemned Government vehicles - Reg.**

Office of the Commissioner, CGST & Central Excise, Nagpur-I Commissionerate, Nagpur is proposing to dispose off two govt. vehicles on **“as is where is basis”**. Details of the said vehicles are as under:-

**2.** Accordingly, sealed quotations are invited for the disposal of the said vehicles on the terms and conditions mention below. Persons/firms, interested in purchasing the above mentioned vehicles, may submit their highest quotations in the enclosed Proforma in a sealed cover addressed to the undersigned **latest by 5.00 PM on or before 20.12.2018** at **Office of the Commissioner, CGST & Central Excise, GST Bhavan, Telanghedi Road, Civil Lines, Nagpur, Preventive Branch, Room No.10**. The bidders or their representatives, not more than one for each quotation, may be present, if they so desired, at the time of opening of Quotations. The cover should be prominently superscripted with the words **“QUOTATION FOR PURCHASE OF CONDEMNED VEHICLE”**.

**3.** The vehicles will be available for inspection between **3.00 PM to 5.30 PM from 10.12.2018 to 14.12.2018 and 17.12.2018 to 19.12.2018** in presence of the Inspector (Prev.), CGST & Central Excise, Preventive Branch, Nagpur-I.

**4. The Auction of the said vehicles will be governed by the following conditions:-**

- i.** The vehicles will be auctioned separately for each vehicle, not through the lot.
- ii.** The vehicles will be sold on “As is where is basis”. The auction process will be conducted in presence of Disposal of Goods Committee.
- iii.** The bidders are required to pay **Earnest Money of Rs.6,500/-** (Rupees Six thousand five hundred only) **for each Maruti Suzuki – Gypsy, separately.**
- iv.** Earnest Money is payable by means of Demand Draft drawn in favour of **Assistant Chief Accounts Officer, CGST & Central Excise, Nagpur-I.** (payment by cheque or cash shall not be accepted)
- v.** Quotations received without demand draft towards Earnest Money will not be considered and shall be rejected.
- vi.** The successful bidder will be required to deposit the bid amount by means of Demand Draft drawn in favour of **Assistant Chief Accounts Officer, CGST & Central Excise, Nagpur-I** within two working days of the acceptance of bid.
- vii.** The Earnest Money of the successful bidder will be released only after the deposit of the bid amount. Earnest Money will not be adjusted as bid amount and will be forfeited, if he fails to honor the bid. In case of failure to deposit final bidding amount, the respective vehicle may once again taken up for re-auction.

**viii.** The delivery of the auctioned vehicles will be arranged only after the successful bidder submits documentary evidence in support of residential status (PAN Card, Aadhar Card etc. in case of individual and Registration Certificate etc. in case of firms).

**ix.** The auctioned vehicles will be removed by the successful bidder within 05 working days on depositing the bid amount, at their own expenses.

**x.** The vehicles will be disposed off on "as is where is basis" and no guarantee for its worthiness or quality will be given by this Department.

**xi.** This Department will not owe any responsibility for transfer of vehicle and for any other liability for using these vehicles for commercial or any other purpose after sale.

**xii.** The successful bidder will also be responsible for getting Registration Certificate of the vehicles and/or any other documents as required by the RTO, in his name at his own cost expeditiously. This Office will not be responsible for any lapse on his part in this regard.

**xiii.** **If, the successful bidder wants to scrap the vehicle, then he should have to submit the cut part of the chassis number to this office immediately.**

**xiv.** The bidder will not be allowed to withdraw their bids and if they do so their earnest money will be forfeited.

**xv.** **The Bid amount is excluding GST, as the GST is to be paid by the recipient of the goods as per the rates applicable.**

**xvi.** The undersigned reserves the right to accept or reject any/all of the quotations without assigning any reason.


