- 4. Further, the empanelled Chartered Engineers would be in addition to the Inspection/Certificate Agencies notified by DGFT in the DGFT's Handbook of Procedures (2021–25), effective via HBP 2023, amended, from time to time. Submission of any wrong information would result in cancellation of Membership of the panel and also attract penal provisions under the Customs Act.
- 5. Empanelled Chartered Engineers have to submit his/her half yearly Self Appraisal Report in the prescribed format, to assess their performance to decide whether they are fit to continue or not. All the Trade Associations/ Chamber of Commerce/ Members of Regional Advisory Committees and Customs Brokers' Association are requested to publicize the contents of this Notice amongst their members/constituents.
