<u>Subject- Role allocation in ICES for the purpose of Warehousing</u> <u>Module- reg.</u>

Kindly refer to CBIC Circular 19/2024 dated 30.09.2024 and Public Notice (PN) No. 08/2025 dated 13.08.2025 regarding Digitization of Customs Bonded Warehouse procedures relating to obtaining Warehouse License, Bond to Bond Movement of Warehoused goods, and uploading of Monthly Returns.

 In this regard, all Systems Managers of the respective Customs Chapter Cells under Nagpur Customs are hereby directed to allocate the prescribed role to the concerned Assistant Commissioner, in accordance with this Office Order.

3. It is further clarified that the above role allocation is solely for the purpose of processing in the Warehouse Module. The statutory functions shall continue to be discharged by the respective Divisional Officers in each Customs Chapter Cell within the jurisdiction of Nagpur Customs. Accordingly, the officers mapped as above shall forward the online application/returns filed to the respective Divisions for further necessary action.
